

# The hit job they put on the engineers of Alpha Team and why “Payback is a Bitch”

Most people may think that “hit-jobs” are the realm of Hollywood movie plots. It turns out, though, corporate assassination and blacklisting attempts actually do take place, daily, in big business and politics. The attack in this story was epic. The pay back was an even bigger “*Go Big or Go Home*” story.

The latest front-page news has detailed the multi-billion dollar Think Progress, Google and Gawker Media-operated character assassination and election-rigging groups that operate some of these attacks. This is the story of one of the group’s attacked by those kinds of vindictive political reprisal efforts and how they fought back.

The following is from records provided to The FBI, federal courts and U.S. Congressional investigators.

Alpha Team invents, engineers and develops products that have, for decades, turned out to be better, smarter and more next-generation than the products of the Silicon Valley/Hollywood Cartel (known as “The SVHC”). The SVHC is run by rich old fraternity house boys who have a standard play-book: ***They can’t figure out how to make anything work but they have lots of cash, so they just spy on small inventors, copy their work, and use litigation-blacklisting to avoid paying their bills.***

A group called Alpha Team has invented and built the first ever versions of technologies that are now world-famous. These technologies have made billions of dollars but often those billions of dollars were made by competitors who put moles inside of Alpha Team and thieved Alpha Team’s intellectual property.

One time, at the request of the U.S. Government, Alpha Team developed and patented an energy technology. That technology accidentally ended up obsoleting trillions of dollars of technology-billionaire insider stock market profits that The SVHC thought that it had a monopoly on. This led to a large ruckus.

Alpha Team members were both “insiders” and “outsiders.” They dated, and/or were close friends with, White House staff from four different White House Administrations. They have won City, State and Federal commendations and acclaim. They have glowing letters, on White House letterhead, from Both Democrat and Republican Administrations. They have hundreds of letters of reference from famous people. Nobody in Alpha Team identifies as either Republican or Democrat. They all say that they are “*politically independent*”.

There was no conceivable reason for political attackers to attack Alpha Team. These engineers were the most politically-averse group in Silicon Valley. They did not want to have anything to do with politics. The attack on Alpha Team was based on pure hubris by The SVHC frat boys!

The opposition attackers have, to date, made over \$45 Billion dollars using exact clones of Alpha Team's technologies, after soliciting Alpha Team in order to spy on their work. The attackers have cost Alpha Team their homes, income and vast billions in damages. Alpha Team lost everything except one asset: ***Their determination!***

Alpha has won commendation from the U.S. Congress in the Iraq War Bill, they have won seminal federal patents, they have won Congressional grants, positive news coverage and the wrath of a handful of insane billionaires who could not compete with Alpha's technology.

The attacks were carried out by California State employees, Gawker Media, Google and corrupt U.S. Government officials who had received payment from these billionaires. Department of Energy Executives and their campaign billionaire handlers engaged in these attacks in order to control the solar and "green car" markets. The technology gangsters did not actually care about green environment issues, they only cared about green cash. Their feigned concern about the environment was a sham. It was just a cover story to rig a Department of Energy slush-fund. The Federal and State employees who ran these retribution campaigns had inside deals they had set up to line their own pockets at taxpayer expense. This was their downfall. They forgot that the FBI and the press are always just around the corner and that the federal government ALWAYS has incriminating files "lost" in some nook and cranny. Those files eventually, *always*, turn up.

In attacking Alpha, The SVHC hired Gawker and Google to run half a decade of attacks in front of 7.5 billion people around the globe. The attackers refreshed the attacks every day and posted them on every HR and investor database on Earth. The attackers personally sent attack materials to the investors, employers, neighbours and spouses of every member of Alpha Team. It was an incredibly sophisticated effort. It almost seemed as if someone had sic'd the CIA on poor old Alpha. While it is a felony for government officials to use the CIA for personal vendettas, it is a more of a grey area to use the CIA's partner: In-Q-Tel, for dirty tricks. Indeed, In-Q-Tel **was** used and got sued by Alpha for their efforts.

## **Speaking of law suits...**

Alpha has filed multiple law suits against those identified by investigators as the culprits in these attacks and thefts of their rights. Currently, the most historically significant Alpha case has had a historical federal court ruling that identified Alpha as having been officially attacked by corrupt federal employees. This may be a U.S. Federal Court historical event in that there is no other U.S. Court record that has, so far, been found that has confirmed federal corruption prior to this ruling.

One of Alpha's goals was to document the corruption they encountered and place detailed recordings of it on permanent public record in the U.S. Court system and in Congressional records. That part of Alpha's goal has now been accomplished. It will now be one hundred times harder for similar kinds of attackers to engage in such corruption, in the USA, ever again.

These corrupt politicians thought they could take over an estimated six trillion dollar "Cleantech" industry that was being manipulated to exploit new marketing opportunities around "global warming" and Middle East disruption. After an epic number of Solyndra-esque failures, all owned by the

Department of Energy executives and their campaign financiers, the scheme fell apart. ([See this 60 Minutes Report](#)) The non crony applicants suffered the worst fates. As CBS News reporter Cheryl Attkisson has reported, the willingness to engage in media "hit jobs" was only exceeded by the audacity with which Department of Energy officials employed such tactics.

Now, in a number of notorious trials and email leaks, including the Hulk Hogan lawsuit and the DNC, Sony, CIA and Panama Papers leaks, the public has gotten to see the depths to which public officials and their Silicon Valley financiers are willing to stoop to ***cheat rather than compete*** in the open market.

Department of Energy employees and State of California employees engaged in the following documented attacks against applicants who were competing with their billionaire backers personal stock holdings. Alpha Team and the other applicants including Bright Automotive, XP, Elio, Aptera, Eco-Motors and many more, suffered these attacks:

- Social Security, SSI, SDI, Disability and other earned benefits were stone-walled. Applications were "lost". Files in the application process "disappeared". Lois Lerner hard drive "incidents" took place.
- State and federal employees played an endless game of Catch-22 by arbitrarily determining that deadlines had passed that they, the government officials, had stonewalled and obfuscated applications for, in order to force these deadlines that they set, to appear to be missed.
- Some applicants found themselves strangely poisoned, not unlike the Alexander Litvenko case. Heavy metals and toxic materials were found right after their work with the Department of Energy weapons and energy facilities. Many wonder if these "targets" were intentionally exposed to toxins in retribution for their testimony. The federal MSDS documents clearly show that a number of these people were exposed to deadly compounds and radiations without being provided with proper HazMat suits which DOE officials knew were required.
- Applicants employers were called, and faxed, and ordered to fire applicants from their places of employment, in the middle of the day, with no notice, as a retribution tactic.
- Applicants HR and employment records, on recruiting and hiring databases, were embedded with negative keywords in order to prevent them from gaining future employment.
- One Gary D. Conley and one Rajeev Motwani, both whistle-blowers and Alpha peers, in this matter, turned up dead under strange circumstances. They are not alone in a series of bizarre deaths related to the DOE.
- Disability and VA complaint hearings and benefits were frozen, delayed, denied or subjected to lost records and "missing hard drives" as in the Lois Lerner case.
- Paypal and other on-line payments for on-line sales were delayed, hidden, or re-directed in order to terminate income potential for applicants who competed with DOE interests and holdings.
- DNS redirection, website spoofing which sent applicants websites to dead ends and other Internet activity manipulations were conducted.

- Campaign finance dirty tricks contractors IN-Q-Tel, Think Progress, Media Matters, Gawker Media, Sid Blumenthal, etc., were hired by DOE Executives and their campaign financiers to attack applicants who competed with DOE executives stocks and personal assets.
- Covert DOE partner: Google, transferred large sums of cash to dirty tricks contractors and then manually locked the media portion of the attacks into the top lines of the top pages of all Google searches globally, for years, with hidden embedded codes in the links and web-pages which multiplied the attacks on applicants by many magnitudes.
- Match.com Honey-traps and employee moles were employed by the attackers. In this tactic, people who covertly worked for the attackers were employed to approach the “target” in order to spy on and misdirect the subject.
- Mortgage and rental applications had red flags added to them in databases to prevent the targets from getting homes or apartments.
- McCarthy-Era "Black-lists" were created and employed against applicants who competed with DOE executives and their campaign financiers to prevent them from funding and future employment.
- Targets were very carefully placed in a position of not being able to get jobs, unemployment benefits, disability benefits or acquire any possible sources of income. The retribution tactics were audacious, overt... and quite illegal.

While law enforcement, regulators and journalists are now clamping down on each, and every, one of the attackers, one-by-one, the DOJ process is slow. The victims have been forced to turn to the filing of lawsuits in order to seek justice.

## Who Are the Attackers and Bad Guys?

Who were the people that FBI, private investigators, Senate staff, news media and former employees of the attackers fingered? Who operated these attacks against Alpha? Who have been submitted to the DOJ, FBI, SEC, FTC, Congress and the voting public for prosecution?
